The Ohio Department of Transportation is currently proposing a pavement remarking maintenance contract and to perform any necessary related work. All work is within the existing right of way and there will be no impacts to utilities. This project is located in a special flood hazard area. All National Flood Insurance Program requirements will be met and coordinated with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2026 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.
