Project Description:

The Ohio Department is currently proposing to resurface State Route 34 from SLM 24.19-28.05 in Williams County due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It was determined by the District 2 hydraulic engineer that there would be no impacts to the floodplain. This project does not include impacts to any waterways, therefore no US Army Corps of Engineers permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2026 and last approximately 120 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
