Project Description:

The City of Wauseon is proposing to resurface Fulton Street from Jefferson Street to Linfoot Street in Fulton County due to poor pavement conditions. All work is within the existing right of way, and there will be no impact to utilities. Since there is no work within any waters of the US and there are no floodplain impacts, no permits are required. There will be no impacts to any state or federally listed species or their habitat. This project has a minimal potential to cause impacts to any historical resources. Construction is expected to begin in the fall of 2025 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.
