Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR420 from SLM0.81 to SLM 2.89 in Wood County due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways, therefore no US Army Corps of Engineers permit is required. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2027 and last approximately 180 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
