Project Description:

The Ohio Department of Transportation is currently proposing to resurface a portion SR 49 between SLM 9.29 to 15.262 and 16.268 to 20.549 in Williams County due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. There will be no impacts to any historically significant resources. Construction is expected to begin in the summer of 2027 and last approximately 120 days. During construction, several 2 to 3-day closures of SR-49 will be required for cross over replacements. Impacted public service agencies and schools have been notified of the closures.

This document was approved based on Stage 2 Plans.
