Project Description:

The City of Bryan is currently proposing to remove failing concrete pavement on N Main St (SR 15 / US 127) between Foster St and Brunicardi Way and replace with new pavement in Williams County. All work is within the existing right of way and there are no anticipated impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2026 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
