Project Description:

The City of Toledo is proposing a project to resurface Glendale Avenue from Detroit Avenue to Charmaine Drive. There will be no impacts to utilities, but permanent right of way will be needed from 3 commercial properties in order to reconstruct a crossing and driveway. Since there is no work within any waters of the US and there are no floodplain impacts, no permits are required. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. This project has a minimal potential to cause impacts to any historical resources. Construction is expected to begin in the summer of 2027 and last approximately 60 days. During construction, a minimum of one lane of traffic in each direction will be maintained.

Cultural Resources Remarks

The literature search concluded there are no inventoried buildings (OHIs), no known archaeological sites (OAIs), and no eligible or listed National Register historic properties in the entire Study Area and/or the area of potential effects (APE). About half of the study area was previously surveyed for cultural resources with negative results. Minor highway maintenance efforts like resurfacing but also ADA ramp and curb upgrades requiring minor right-of-way are activities which are exempt from further cultural resource consideration by the 6/29/23 Cultural Resource PA (Agreement 38503), if the project is not within the boundaries of any historic property or N. R. district.

Air Remarks

The project does not add capacity, a new interchange or a new road on new alignment. This project only slightly modifies an existing alignment. Hence this project will not result in any meaningful changes in traffic volume, vehicle mix, location of the existing facility, or any factor that would cause an increase in emissions impacts relative to the no-build alternative. The project is exempt under 40 CFR 93.126. No air quality analysis is required.

Noise Remarks

The project does not qualify as a Type I project for noise (i.e. not adding capacity to thru lanes, not moving thru travel lanes equal to or greater than 50% closer to noise sensitive areas) and a noise analysis is not required for the project under 23 CFR 772.
