Project Description:

The City of Bowling Green is proposing a project to install sidewalk along S. Wintergarden Rd from North Street to Wintergarden Park. Permanent and temporary right of way is required from 1 residential parcel and there will be no impact to utilities. Since there is no work within any waters of the US and there are no floodplain impacts, no permits are required. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. This project has a minimal potential to cause impacts to any historical resources. Construction is expected to begin in the summer of 2027 and last approximately 60 days. During construction, a minimum of one lane of traffic in each direction will be maintained. Access to Wintergarden Park will also be maintained throughout construction. This document was written and approved based on Stage 2 plans

The project does not add capacity, a new interchange or a new road on new alignment. This project only slightly modifies an existing alignment. Hence this project will not result in any meaningful changes in traffic volume, vehicle mix, location of the existing facility, or any factor that would cause an increase in emissions impacts relative to the no-build alternative. The project is exempt under 40 CFR 93.126. No air quality analysis is required.
