Project Description:

The City of Perrysburg is proposing to resurface State Route 199 (Louisiana Ave) from Indiana Ave to Scheider Rd. All work is within the existing right of way, and there will be no impact to utilities. Since there is no work within any waters of the US, so no USACE permits are required. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. This project has a minimal potential to cause impacts to any historical resources. Construction is expected to begin in the summer of 2027 and last approximately 60 days. During construction, a minimum of one lane of traffic in each direction will be maintained. This document was written and approved based on Stage 2 plans
