Project Description:

This project is to complete a structure repair of the median parapet on US 6 over the Sandusky River in Sandusky County due to poor bridge conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. There will be no impacts to any historically significant resources. Construction is expected to begin in the spring of 2027 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.
