Project Description:

ODOT is proposing a project to paint the structural steel of 2 structures in Seneca County. All work is within the existing right of way, and there will be no impact to utilities. Since there is no work within any waters of the US and there are no floodplain impacts, no permits are required. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. This project has a minimal potential to cause impacts to any historical resources. Construction is expected to begin in the summer of 2027 and last approximately 45 days. During construction, there will be a temporary road closure of 45 days required for SEN-18-2.76 structure. All impacted public safety agencies and schools have been notified of the upcoming road closure.
