Project Description:

The City of Port Clinton in Ottawa County is currently proposing to construct sidewalk for safety reasons on roads including Jefferson St, 11th St, Ann St, and Monroe St along with any necessary related work. All work is within the existing right of way and there may be impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any historically significant resources. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. Construction is expected to begin in the fall of 2026 and last approximately 30 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
