Project Description:

The Ohio Department of Transportation (ODOT) plans to improve a total of 2.74 miles along State Route (SR) 45 in Warren and Champion Townships, Trumbull County. The project proposes to microsurface 1.95 miles of SR 45 from Straight Line Mile (SLM) 9.17 to SLM 9.87 in Warren Township and from SLM 11.65 to SLM 12.90 in Champion Township. Additionally, the project proposes to double microsurface 0.79 mile of SR 45 from SLM 9.87 to SLM 10.66 in Warren Township. Further improvements include partial depth pavement repairs, the application of center/edge/stop lines and the installation of raised pavement markers throughout the proposed microsurfaced pavement sections.

During project construction, a minimum of one (1) 10-foot lane of traffic shall be maintained in each direction on the existing pavement and completed pavement. No substantial traffic disruptions are anticipated with the project.

Based on the project scope of work, its Path 1 Preliminary Development Process (PDP) Classification and the proposed maintenance of traffic measures, emergency/public services contact activities were not conducted for the project.

The project will be constructed within the existing roadway right-of-way.

Existing utilities within the project study area will not be impacted/relocated to construct the project.

Based on the proposed scope of work, the project has minimal potential to cause effects to historic properties under Appendix A. The project will not impact any environmentally sensitive resources within the project study area.

The environmental document and associated studies, as applicable, were approved using the preliminary scope of work for the project. When available, the project plans will be reviewed by ODOT District 4 Environmental Section personnel and uploaded to the Project File/General/Project Information subsection as Stage 3 Design.pdf.
