Project Description:

The Ohio Department of Transportation (ODOT) proposes spot pavement repairs along various routes throughout Ashtabula, Mahoning and Trumbull Counties.

During project construction, normal directional traffic shall be maintained on the highways/roadways at all times. No substantial traffic disruptions are anticipated with the project.

Based on the project scope of work, its Path 1 Preliminary Development Process (PDP) Classification and the proposed maintenance of traffic measures, emergency/public services contact activities were not conducted for the project.

The project has no Federal funding (100% State funded project), does not involve a Federal action and will be constructed within the existing highway/roadway rights-of-way.

Existing utilities within the project study areas will not be impacted/relocated to construct the project.

The project will not impact any environmentally sensitive resources within the project study areas.

The preliminary scope of work was utilized to evaluate potential environmental impacts by and obtain NEPA approval for the project. When available, the project plans will be reviewed by ODOT District Environmental Section personnel to confirm the project will not impact any environmentally sensitive resources within the project study areas and uploaded to the Project File.
