Project Description:

The Lucas County Engineers Office is resurfacing McCord Rd from Hancock Ave to Dorr St. Additional work includes a small stretch of sidewalk and curb ramps. All work is within the existing right of way and there will be no utility impacts. There is no requirement for any waterway permits and the required floodplain permit has been obtained. There is no suitable habitat for any state or federally listed species within the project area and there is minimal potential to have effects on any historical resources. Construction is expected to begin in the summer of 2019 and last approximately 45 days. During construction, a minimum of one lane of traffic on McCord Rd will be maintained at all times.

This document was written and approved based on Stage 2 plans.

The contractor shall immediately remove through non-mechanical means any material that falls into the roadside ditches, streams, wetlands, or other waters. Under no circumstances shall the contractor work in or store equipment and/or materials in any wetlands, streams, or other waters. No work or staging is permitted below the top of bank of any stream and/or within a wetland.
