Project Description:

The Ohio Department of Transportation is proposing to resurface State Route 120 in Fulton County from Country Road 7 to the western Metamora Corporation Limits. Additional work includes minor maintenance (replace deck edges and guardrail) on 3 bridges. All work is within the existing right of way and there will be no impacts to any utilities. There are no permits from the US Army Corps of Engineers required and the project is not located within a floodplain. There are no impacts to and ecological resources and is there for exempt from any ecological studies and coordination (documentation in file). This project will also have no impacts on any historically significant resources. Construction is expected to begin in the summer of 2019 and last approximately 60 days. During construction, two of the bridges will require temporary closures of 45 and 3 days, which will happen concurrently. A detour will be posted throughout construction. All impacted property owners, residents, emergency services and schools have been notified of the closure.

This document was approved based on stage 2 plans.

The contractor shall immediately remove through non-mechanical means any material that falls into the roadside ditches, streams, wetlands, or other waters. Under no circumstances shall the contractor work in or store equipment and/or materials in any wetlands, streams, or other waters. No work or staging is permitted below the top of bank of any stream and/or within a wetland.
