Project Description:

The City of Toledo is proposing to resurface State Routes 25 and 120 (Cherry Street) from Summit Street to Greenbelt Pkwy in Downtown Toledo. All work is within the existing right of way and there will be no utility impacts. No US Army Corps of Engineers permits or Floodplain permits required since the project is not impacting any waterways or floodplains. There will be no impacts to any ecologically significant resources and there is minimal potential to cause effects to any historical sites. Construction is expected to begin in the summer of 2019 and last approximately 60 days. During construction, a minimum of one lane of traffic will be maintained at all times.

This document was written and approved based on Stage 1 plans.
