Resurfacing from SR-528 to the Lake County Line in Thompson Twp.

All work within existing r/w.

A Cultural Resources Records Check was performed by district environmental staff Corey Czinger, Environmental Specialist, using the SHPO Records Request via email. No Cultural Resources listed on or determined eligible for listing on the National Register of Historic Places were identified within the proposed project area. The undertaking is a type which has minimal potential to cause effects to historic properties in accordance with Minimal Potential to Cause Effect - Appendix A of the Section 106 Programmatic Agreement. FEMA Flood Zone A is on both sides of Plan Road in the southern area over the North Branch Phelps Creek. This C1-level resurfacing project has such a remote chance of affecting base food elevation that it is excluded from analysis.

Construction: \$780,000.00: 80% federal and 20% state.
