Resurfacing from Newell St to US-20 in the City of Painesville and Painesville Township.

Funding:

Preliminary engineering: 100% state

Construction: 80% federal and 20% state

All work within existing r/w.

No Cultural Resources listed on or determined eligible for listing on the National Register of Historic Places were identified within the proposed project area. The resurfacing of SR-2 is located in a floodplain. This C1-level resurfacing project has such a remote chance of affecting base flood elevation that it is excluded from analysis.
