**Project Description:**

Painting the structural steel of 7 structures along the I-480 corridor from SR-237 to Tuxedo Ave. Spot painting at one (1) structure along IR-271 at SR-87 (Chagrin Blvd.).

All work within existing ROW.

A Cultural Resources Records Check was performed by district environmental staff Corey Czinger, Environmental Specialist 3, using the online OSHPO ArcMap Resource Map. No Cultural Resources listed on or determined eligible for listing on the National Register of Historic Places were identified within the proposed project area. The undertaking is a type which has minimal potential to cause effects to historic properties in accordance with Minimal Potential to Cause Effect - Appendix A of the Section 106 Programmatic Agreement. This project is not located in a floodplain. This C1-level deck replacement project has such a remote chance of affecting base flood elevation that it is excluded from analysis.
